MINUTES OF THE REGULAR MEETING OF THE BOARD OF DIRECTORS OF THE EAST ORANGE COUNTY WATER DISTRICT (EOCWD)

July 25, 2024

1. <u>Call to Order</u>. A Regular Meeting of the Board of Directors of the East Orange County Water District, held at the District Office, located at 185 N. McPherson Road in the City of Orange, California, was called to order by President DOUGLASS DAVERT at 5:00 p.m. on Thursday, July 25, 2024, with Director JOHN NIELSEN leading the Pledge of Allegiance. Public attendance was permitted in-person only. JEFFREY HOSKINSON, Secretary, recorded the minutes of the meeting.

<u>Consent Calendar</u>. The Board, after a brief report from General Manager Youngblood on the General Manager's report and inquiry from Director SEARS relative to customer sewer refunds, on motion from NIELSEN, seconded by MURDOCH, approved the Consent Calendar by unanimous vote as follows:

Matters for Consideration.

9. Septic to Sewer Conversion for 1892 E. Lemon Heights. Micah Fromkin requested a waiver from the Board for his connection charges to the EOCWD sewer system, explaining that his home is currently on septic and he is required to pay approximately \$18,000 in connection fees as a result of his construction of an accessory dwelling unit (ADU) that is requiring that both his home and ADU be connected to the sewer. Connecting to the sewer, due to the distance from the current line, will cost him approximately \$100,000. President DAVERT discussed concerns relative to a waiver of fees, including Proposition 218 limitations and an inability to subsidize customers by requiring other customers to cover expenses. On inquiry from President DAVERT, General Counsel Hoskinson confirmed that the granting of a waiver could create legal precedent for similar situated properties, and that it could create a Proposition 26 issue where fees collected from others were considered more than actual costs if not all properties were contributing. Director THOMS inquired as to payment or installment agreement plans, which General Counsel Hoskinson indicated that other agencies have used such tools to allow payment over time.

<u>ACTION TAKEN</u>: The Board, on motion from SEARS, seconded by THOMS, by unanimous vote denied the request for a waiver of connection fees, but directed that the homeowner could work with General Manager Youngblood to explore an installment payment plan.

10. Townsend Contract. General Manager Youngblood introduced the item, with brief comments from Eric O'Donnell of Townsend Public Affairs, including a brief report on current legislative items.

<u>ACTION TAKEN</u>: The Board, on motion duly seconded, by unanimous vote approved a two-year contract with Townsend Affairs, with compensation of \$3,500 per month for the first year, and \$4,000 per month for the second year.

11. Sewer Service Charges. General Manager Youngblood introduced the item, relative to the annual proposed resolution to collect sewer charges on the property tax roll.

<u>ACTION TAKEN:</u> The Board, on motion by SEARS, seconded by NIELSEN, by unanimous vote approved Resolution No. 945, directing the County Tax Collector to collect the sewer charges on the Fiscal Year 2024-25 property tax bills.

12. VanderWerff Well Final Acceptance. General Manager Youngblood introduced the item, with discussion over the excellent work by Pascal and Ludwig, despite difficulties due to a



non-performance by a subcontractor. It was noted that the final contract for the well was \$1.4 million, and that Pascal and Ludwig is voluntarily closing its doors. It was recommended that the Board approve the Notice of Completion for the Project.

ACTION TAKEN: The Board, on motion by NIELSEN, seconded by THOMS, by unanimous vote (1) increased the budget by \$10,068 and authorized the General Manager to execute the final change order in the amount of \$29,168; (2) accepted the construction of the VanderWerff Well Equipping Project; (3) authorized the General Manager to file a Notice of Completion; and (4) authorized payment of the retention 35 days after the date of recording the Notice of Completion.

The following report is a summary of the District's activities over the past month.

SEWER

1) ID1 Update

Update

Eight (8) permits were issued in August; four (4) for ADUs, two (2) in the City of Tustin, one (1) in the City of Orange, and one (1) in the unincorporated area; three (3) for SFR remodels, one (1) in the City of Orange, one (1) in the City of Tustin, and one (1) in the unincorporated area; and one (1) permit for a new SFR in the unincorporated area.

WHOLESALE ZONE

1) WZ Water Demands

2) Water Quality Update

On September 6, 2023, Metropolitan Water District of Southern California (MWD) provided a water quality notice informing member agencies that the Diemer plant service area was experiencing nitrification. To address this MWD implemented several operational changes at the Diemer plant which included raising plant effluent pH, maintaining a plant effluent total chlorine residual of 2.7 mg/L, and minimizing free ammonia leaving the plant. In addition, the source water blend for the Diemer plant was lowered from approximately 80 percent State Water Project (SWP) to 25 percent.

Once MET made the changes described above, staff was able to see significant improvements in water quality throughout the WZ system.

Update: Water quality throughout the system remains good. No issues to report.

3) WZ Connection Permits

Four (4) permits were issued in July; three (3) in the unincorporated area and one (1) in the City of Orange

Four (4) permits were issued in August; two (2) in the City of Tustin and two (2) in the unincorporated area.

RETAIL ZONE

1) <u>Water Demand</u> – see attachments

2) East Orange DroughtReach[™] Program

Update: RZ Demand in July was equal to July 2023 while August demand was 2% lower than August 2023. Water efficiency messaging continues through social media and print media (Foothill Sentry).

3) Well / Booster Station Operations

On June 25, 2024, EOCWD resumed delivery of groundwater to the retail water system. The District has not served any groundwater to this point since May of 2019. Going forward, one-hundred percent of retail system demands will be met using groundwater at least until the end of 2024. The current basin pumping percentage is 85%.

Well Levels – Update: Water levels have declined over the last 2 months as shown on the attached graph. The pumping water level for the East Well in August was 226 feet BGS (below ground surface) while the VanderWerff Well pumping water level was 232 feet BGS. Please note that the VanderWerff Well continues to pump 24/7 at a flow rate between 1,000 and 1,400 gpm. Historically pumping water levels have been as low as 297 feet BGS back in July 2014).

4) Circula Panorama Pipeline Conversion (Zone 3 to 2) and Replacement Project

Update: The installation of the pipeline portion of the project is complete. The contractor is installing appurtenances (fire hydrant, airvacs, and service lines) and three PRV vaults. Project completion is expected in November.

5) System Leaks

On July 11, staff repaired a mainline leak on Marcy Drive which was discovered by staff early in the week as a damp spot in the pavement. A repair clamp was installed on the 8" ac pipe which had a circumferential crack. Service was not interrupted to any customers. The cause of the leak was ground movement.

On July 29th, staff was notified by a resident of a possible leak on Cresthaven Lane. Upon further investigation, staff determined that there was a leak on a tee connection at the south end of Cresthaven Lane which interrupted service to 5 residents. Staff excavated, removed and replaced the push-on tee connection with a restrained system. The cause of the leak was ground movement.

On August 27th, a resident reported a possible leak at Fairhaven Extension and Via Aventura. Upon investigating, staff determined that there was a leak on the existing 1" plastic service line. A new copper service was installed.

6) <u>Water Availability Request/Connection Permits</u>

- Ordered misc. tools, parts, and materials for water and sewer departments.
- Completed Dig Alerts.
- Monitored daily operations of treatment plant, reservoir chlorination system at Andres reservoir (Ops. Manager).
- Attended Groundwater Producer Meetings (Eng. Manager).
- Submitted monthly, quarterly, and annual reports to SWRCB.
- Reviewed weekly water quality data.
- Ordered water quality supplies.
- Attend weekly maintenance and operations meeting with GM (Engineering and Ops. Managers).

Minutes of the Engineering & Operations Committee September 12, 2024

1. The meeting was called to order at 9:00 a.m. by Director Murdoch.

The following Directors attended the meeting: Director Murdoch and Director Thoms. Also present at the meeting were: David Youngblood – General Manager, Jeff Smyth – Engineering Manager, Jerry Mendzer – Operations Manager, and Sylvia Prado – Office Manager.

- 2. No public comments were received.
- 3. No additional items were added to the agenda.

Informational Items

- 4. Retail Zone (RZ) Well Levels, System Status, and Water Use Staff informed the committee regarding well usage and Retail Zone activities. The VanderWerff Well is currently being used to supply groundwater, however, the East Well will be used in the future, both separately and in conjunction with the VanderWerff well. EOCWD has been providing groundwater to GSWC and the City of Tustin through the Wholesale Zone. The treatment plant has been operating well with only minor issues since June 25 when groundwater pumping commenced. Staff completed the inventory for the lead and copper rule and no lead services were identified. Staff completed repairs on Marcy Drive and Cresthaven. The Brae Glen pipeline is complete, only surface restoration remains. The Circula Panorama Zone 3 to 2 pipeline is complete and the contractor is working on PRV vaults and appurtenances. Staff reported the County began work on Crawford Canyon Park.
- 5. Wholesale Zone (WZ) System Status and Water Use Staff informed the committee the District and GSWC have not taken any import water. The City of Tustin received 60 acft of groundwater water in July and 70 acft in August. GSWC is utilizing groundwater from their well and EOCWD. Basin Equity Assessment (BEA) costs will be paid by EOCWD and allocated to each retail agency. EOCWD will pass the groundwater costs including electricity, chemicals, etc. on to the retail retailers without markup. Director Thoms mentioned communicating publicly about helping GSWC and City of Tustin with groundwater and lowering their water costs. Staff informed the Committee regarding challenges with the treatment trailer at the 11.5 MG Andres reservoir and vegetation maintenance (goats) at the 6MG reservoir.
- 6. Sewer System Status and Permit Reports Staff informed the committee there were no sewer spills and staff completed NASCCO Pipeline Assessment Certification training.

Action Items

- 7. Vista Panorama Pipeline Improvements Change Order Staff presented the item to the Committee and the Committee ratified the change order in the amount of \$8,718 to Doty Bros. Construction.
- 8. SCADA Phase 2 Contract Award Staff presented the item to the Committee. Director Murdoch inquired about the overall project costs, the project budget increase and basis, and the fiscal year project budget increase. Staff explained the project phases, the history and basis of

the system replacement, and the need to increase both the overall project budget and Fiscal Year project budget which is confusing and difficult to explain. The Committee offered suggestions to clarify the information and recommended presenting to the Board with changes.










Annual Water Usage









Background

The purpose of this resolution by the East Orange County Water District (EOCWD) Board of Directors is to adopt a new Conflict of Interest Code that supersedes all previous versions, as part of the regular bi-annual review of such policy. This update is necessary to comply with the Political Reform Act of 1974, which mandates local government agencies to maintain an up-to-date Conflict of Interest Code. The new code incorporates the standard model terms set forth by the Fair Political Practices Commission, which helps streamline the process and ensure conformity with state regulations. Additionally, the resolution addresses the inclusion of a new designated position, "GIS Manager."

The resolution also outlines the procedures for filing statements of economic interests. Members of the Board of Directors, the General Manager, and the Treasurer are required to file their statements with the County of Orange using the County's eDisclosure System. Other designated positions will file their statements with the District, which will make them available for public inspection. The resolution ensures that the Conflict of Interest Code remains current and compliant with any future amendments to the Political Reform Act, thereby promoting transparency and accountability within the EOCWD.

RESOLUTION NO. 947

RESOLUTION OF THE BOARD OF DIRECTORS OF THE EAST ORANGE COUNTY WATER DISTRICT ADOPTING A CONFLICT OF INTEREST CODE WHICH SUPERSEDES ALL PRIOR CONFLICT OF INTEREST CODES AND AMENDMENTS PREVIOUSLY ADOPTED

WHEREAS, the Political Reform Act of 1974, as set forth in Government Code Section 81000 *et seq*. (the "Act"), requires a local government agency to adopt a Conflict of Interest Code pursuant to the Act; and

WHEREAS, the East Orange County Water District ("EOCWD") has previously adopted a Conflict of Interest Code and that Code now requires updating in light of the addition of a new designated position; and

WHEREAS, amendments to the Act have in the past and foreseeably will in the future require conforming amendments to be made to the Conflict of Interest Code; and

WHEREAS, the Fair Political Practices Commission has adopted a regulation, Title 2, California Code of Regulations, Section 18730, which contains terms for a standard model Conflict of Interest Code, which, together with amendments thereto, may be adopted by public agencies and incorporated by reference to save public agencies time and money by minimizing the actions required of such agencies to keep their codes in conformity with the Political Reform Act;

WHEREAS, EOCWD has added a position of "GIS Manager," which constitutes a new designated position.

NOW, THEREFORE, the Board of Directors of the East Orange County Water District DOES HEREBY RESOLVE, DETERMINE AND ORDER as follows:

Section 1. The terms of Section 18730 of Title 2 of the California Code of Regulations, as well as any amendments to Section 18730 duly adopted by the Fair Political Practices Commission, are hereby incorporated by reference and, together with Exhibits A and B in which members and employees are designated and disclosure categories are set forth, constitute the Conflict of Interest Code of the East Orange County Water District.

<u>Section 2</u>. The provisions of all Conflict of Interest Codes and Amendments thereto previously adopted by EOCWD are hereby superseded.

Section 3. Members of the Board of Directors, the General Manager, and Treasurer shall file their statements with the County of Orange ("County") utilizing the County's eDisclosure System. All other designated positions shall file their statements of economic interests with the District, which will make the statements available for public inspection and reproduction per Government Code Section 81008.

Section 4. "Consultants/New Positions" are included in the list of designated positions and shall disclose pursuant to the broadest disclosure category in the Conflict of Interest Code, subject to a written determination from the General Manager that the particular consultant or new position, although a designated position, is hired to perform a range of duties that is limited in scope and thus is not required to fully comply with the disclosure requirements in this Section 4. Such written determination shall include a description of the duties of the consultant or new position and, based on that description, a statement of the extent of disclosure requirements. The General Manager's determination is a public record and shall be retained for public inspection in the same manner and location as this Conflict of Interest Code, per Government Code Section 81008.

Section 4. The Secretary of the District (Filing Officer) is hereby authorized to forward a copy of this Resolution to the Clerk of the Orange County Board of Supervisors for review and approval by the Orange County Board of Supervisors as required by California Government Code Section 87303.

STATE LEGISLATIVE UPDATES

July 3 marked the beginning of the Legislature's month-long Summer Recess, with legislators returning on August 5. Despite the lack of legislative activity during the month of July, it was a critical time for behind-the-scenes negotiations on bills and funding activity as the Legislature gears up to tackle the final month of the 2023-2024 Legislative Session. Upon their return on August 5, lawmakers had over a thousand measures to consider and pass prior to their adjournment on August 31. Following this legislative session's adjournment, the Governor will have until September 30 to sign or veto bills.

In addition to the behind the scenes work this month, July also marked a critical milestone for the finalization of statewide ballot initiatives California voters will consider at the November 5, 2024 General Election. Prior to its departure for summer recess, the Legislature finalized two final bond proposals to fund projects related to climate resiliency and school facility improvements. The two bond measures will appear among eight other ballot initiatives, ranging from local rent control to serial theft prevention, and tax reforms.

Below is an overview of pertinent state actions from the month of July.

The Legislature's Return in August

Upon the legislators' return from their Summer Recess on August 5, fiscal committee hearings and House Floor sessions resumed at an accelerated pace. The upcoming legislative deadline on August 16 marks the point by which measures must pass out of their respective fiscal committees (in the opposite house) to proceed to the opposite House Floor for a final vote.

Assembly and Senate Appropriations Committees will be considering legislation that originated in the opposite house and has an unabsorbable fiscal impact to the state. Typically, any bill with a fiscal impact exceeding \$150,000 is placed on the fiscal committee's Suspense File. Measures placed on the suspense file will face consideration during the Appropriation Committees' "suspense hearing" on August 15. These hearings feature the rapid reading of measures and their status. Measures that are passed out of the Suspense File are moved to each House Floor for a final vote.

From August 19 through August 31, each House Floor will conduct floor sessions only, during which measures must pass off the Floor, in order to advance to the Governor's desk for a signature or veto. Measures must pass out of each House Floor by the August 31 deadline, which will begin the Legislature's Final Recess upon adjournment.

Below is a list of notable measures, organized by policy area, that will be heard in upcoming fiscal committees:

Environmental Quality

- <u>AB 347 (Ting)</u> requires the Department of Toxic Substances Control (DTSC) to enforce compliance with existing and future product safety laws regulating the use of PFAS chemicals.
- <u>AB 2236 (Bauer-Kahan)</u> revises the single-use carryout bag exception to include bags provided before the point of sale designed to protect purchased items starting January 1, 2026, and changes the definition of a "recycled paper bag" to require at least 50% postconsumer recycled materials by January 1, 2028. Additionally, this measure prohibits stores from providing any bags at the point of sale, except as specified.
- <u>AB 2346 (Lee)</u> allows local jurisdictions to receive credit for purchasing recovered organic waste products through agreements with direct service providers, including on a prospective basis. Additionally, this measure permits counting compost from certain operations and related investments towards procurement targets, with the Department of Resources Recycling and Recovery reevaluating per capita procurement targets periodically. AB 2346 allows local jurisdictions to set local procurement targets based on waste characterization studies and allows for exceeding these targets over five years, with an emphasis on prioritizing local compost use.

Housing and Land Use

- <u>AB 1886 (Alvarez)</u> clarifies that a housing element or amendment is not considered substantially compliant with housing element law until the local agency has adopted a housing element that the Department of Housing and Community Development (HCD) has determined is in substantial compliance with housing element law.
- <u>AB 2023 (Quirk-Silva)</u> creates a rebuttable presumption that a local government's housing element or amendment is invalid if HCD found that the housing element or amendment is not substantially in compliance with housing element law and makes various changes to the housing element process.
- <u>AB 2485 (Carillo)</u> seeks to enhance transparency in HCD's regional housing needs calculation process by creating an advisory panel and requiring the publication of methodologies used on HCD's website.
- <u>AB 3093 (Ward)</u> creates two new income categories, Acutely Low Income (ALI) and Extremely Low Income (ELI), in the Regional Housing Needs Determination (RHND),

Regional Housing Needs Allocation (RHNA), and Housing Element Law, among other provisions.

 <u>SB 937 (Wiener)</u> removes from existing law, the ability of a local agency to collect impact fees or charges on "priority residential development projects," as defined, before the final inspection or the date of the certificate of occupancy for all residential developments in all circumstances.

Governance and Transparency

- <u>AB 2557 (Ortega)</u> restricts local governments' ability to contract out for a variety of services.
- <u>AB 2561 (McKinnor)</u> requires public agencies with high vacancy rates to meet and confer with the representative of employee organizations about strategies to fill vacancies, and to hold a public hearing regarding the vacancy rates. The bill also stipulates possible strategies agencies may use to fill vacancies.
- <u>AB 2631 (Fong)</u> requires the Fair Political Practices Commission (FPPC) to provide an ethics training course to local officials.

Report Released on the Public Health Impacts of Wildfire and Policy Recommendations

In mid-July, the Center for Law, Energy, and Environment (CLEE) at UC Berkeley held a briefing and panel discussion on its report, "<u>Scoping the Public Health Impacts of Wildfire</u>," which was released this spring. The report discusses current research on the health impacts of wildfire, reviews key issues, provides an overview of the current policy landscape, and identifies recommendations for future resilience.

In recent years, the rapid increase of wildfires throughout the state has caused a significant rise in public safety impacts, including the toll on mental health and the social consequences caused by catastrophic wildfires. However, the public safety impacts have yet to be fully integrated into current policies. According to the report, the lack of policy integration stems from the early stages of research on the public health issues caused by wildfires, as well as the complex public health challenges, which have made it difficult to address these issues with existing policies.

The report makes the following recommendations for policymakers:

- 1. Enhancing proactive capacity-building to address wildfire risk in the near term, by expansions in the wildland fire sector workforce, research capabilities, data collection and monitoring, wildfire smoke protection resources, emergency response, and wildfire preparedness.
- Facilitating the responsible implementation of ecologically beneficial fire, by establishing integrated, community-led governance principles, developing multifaceted policies, conducting public education and outreach, and significantly expanding research on the effects of prescribed fires.

3. Building systems-level resilience in wildland fire and public health, by facilitating coordinated, streamlined governance structures, developing integrated air quality regulation frameworks, mitigating climate change, and incorporating wildland fire safety into broader policy areas, such as housing and occupational protections.

It can be anticipated that the Legislature will hold future oversight and informational hearings in late 2024 through early 2025, to increase disaster preparedness and wildfire resilience policies.

FEDERAL UPDATES

LEGISLATIVE BRANCH ACTIVITY

FY2025 Appropriations Updates

During the month of July, the Senate Committee on Appropriations advanced all twelve Fiscal Year (FY2025) funding bills. Each vote comfortably passed out of the committee thus signaling the same will likely occur on the Senate floor. As of the end of July, Senate Majority Leader Chuck Schumer has not stated when he intends to schedule a vote.

- The FY2025 Transportation, Housing and Urban Development (THUD), and Related Agencies Appropriations Act provides \$98.7 billion in total discretionary funding. It includes \$1.4 billion for the HOME Investment Partnerships Program and \$550 million for the RAISE Grant program.
- The FY2025 Commerce, Justice, Science, and Related Agencies Appropriations Act provides a total of \$73.7 billion in discretionary funding.
- The FY2025 Interior and Environment, and Related Agencies Appropriations Act provides \$44.6 billion in total funding. Included is \$1.9 billion allocated from the National Parks and Public Lands Restoration Fund for deferred maintenance projects.
- The Agriculture-FDA package would increase funding for the Special Supplemental Nutrition Program for Women, Infants, and Children to \$7.7 billion. Senate Appropriations Chair Patty Murray championed an \$83 million increase to housing rental assistance, to \$1.7 billion. Veterans Affairs medical care would see a decrease to \$112.6 billion, down from \$121 billion in FY2024.

A committee summary noted that the FY2025 figure will be augmented by money previously approved for the Cost of War Toxic Exposures Fund. Chair Patty Murray and Vice Chair Susan Collins agreed to add billions in emergency funding: \$13.5 billion for nondefense and nearly \$21 billion for defense. The White House has called for the replenishment of the FEMA emergency fund, which would be addressed in this package.

The House has struggled to pass their spending packages on the floor as multiple attempts have failed. This is due to partisan policy riders that have been rejected on the floor. Once resolved, the Chairs and Ranking Members of both the Senate and House Appropriations Committees will resolve their differences over the remainder of the year. It is possible that all appropriations

packages will be approved by both chambers during the lame duck session after the election, but could extend into early 2025

EXECUTIVE BRANCH ACTIVITY

FEMA's Disaster Fund Nears Depletion

The Federal Emergency Management Agency (FEMA) has denied aid to a growing roster of municipalities as it copes with natural disasters that are increasing in frequency, strength, and cost. FEMA is working with the Biden Administration and Congress to ensure that sufficient funding is made available. If not, state and local governments will be forced to pay more long-term. Lawmakers are considering a supplemental spending package, but it is not expected to move until September at earliest—either prior to the Sept. 30 shutdown deadline or attached as an amendment to a potential continuing resolution.

To emphasize the urgency, FEMA is managing 500 open disaster declarations going back sometimes 20 years to Hurricane Katrina according to government officials. The US has been hit by 15 weather and climate disasters that cost at least \$1 billion this year, on top of 28 such events last year. FEMA is also stretched thin by an expanded mission and captive to a hyper-partisan federal budget process. Its Disaster Relief Fund could be depleted by mid-August without additional money from Congress, said Homeland Security Secretary Alejandro Mayorkas. The agency's most recent monthly report said the fund faces a deficit in excess of \$6 billion without supplemental appropriations. For local governments, it is becoming harder to acquire federal disaster aid for things like rebuilding damaged infrastructure in the aftermath of large-scale events. Last year, FEMA denied 14 aid requests, the most since 2016.

FEMA Finalizes New Rule Guiding Use of Funds

FEMA has finalized a rule mandating that projects built using its funds consider the future risk of flooding. FEMA officials said that the updated Federal Flood Risk Management Standard will go into effect on September 9. The stated goal of the regulation is to make communities more resilient and save taxpayers money by preventing repeat building of vulnerable structures in flood zones.

Summary: Current law establishes the Atmospheric Rivers: Research, Mitigation, and Climate Forecasting Program within the department to, upon appropriation of special fund moneys, research climate forecasting and the causes and impacts that climate change has on atmospheric rivers, to operate reservoirs in a manner that improves flood protection in the state, and to reoperate flood control and water storage facilities to capture water generated by atmospheric rivers. This bill would establish the State-Federal Flood Operations Center within the Department of Water Resources and would authorize the department to administer the center in the department's divisions, offices, or programs. The bill would provide that the purpose of the center is to function as the focal point for gathering, analyzing, and disseminating flood and water-related information to stakeholders and would authorize the center to take specified actions for that purpose, including to function during emergency situations to enable the department to centrally coordinate statewide emergency responses. (Based on 07/03/2023 text)

AB 347 (Ting, D) Household product safety: toxic substances: testing and enforcement.

Status: 08/05/2024 - In committee: Referred to APPR suspense file.



Location: 08/05/2024 - Senate APPR. SUSPENSE FILE

Summary: Current law prohibits juvenile products, textile articles, and food packaging that contain specified levels of perfluoroalkyl and polyfluoroalkyl substances (PFAS) from being distributed, sold, or offered for sale in the state, as provided. This bill would require the Department of Toxic Substances Control, on or before January 1, 2026, to adopt regulations for the enforcement of those prohibitions on the use of PFAS. The bill would require manufacturers of these products, on or before July 1, 2026, to register with the department, to pay a registration fee to the department, and to provide a statement of compliance certifying compliance with the applicable prohibitions on the use of PFAS to the department, as specified. The bill would authorize the department to test products and to rely on third-party testing to determine compliance with prohibitions on the use of PFAS, as specified. The bill would authorize or require, as specified, the department to issue a notice of violation for a product in violation of the prohibitions on the use of PFAS, as provided. (Based on 07/03/2024 text)

AB 460 (Bauer-Kahan, D) State Water Resources Control Board: water rights and usage: civil penalties.

The act requires the registration of water use to be made upon a form prescribed by the board that requires,

among other things, a certification that the registrant has contacted a representative of the Department of Fish and Wildlife and has agreed to comply with conditions set forth by the department. The act requires the board to establish reasonable general conditions to which all appropriations made pursuant to the act are required to be subject, including, among other things, that all conditions lawfully required by the department are conditions upon the appropriations. The act provides that the board is not required to adopt general conditions for small irrigation use until the board determines that funds are available for that purpose, and that a registration for small irrigation use pursuant to the act is not authorized until the board establishes general conditions for small irrigation use to protect instream beneficial uses, as specified. This bill would require the board to give priority to adopting, on or before June 30, 2027, except as provided, general conditions that permit specified registrants to store water for small irrigation use during times of high streamflow in exchange for those registrants reducing diversions during periods of low streamflow, as specified. Current law requires a local agency to adopt the model ordinance or to adopt a water efficient landscape ordinance that is at least as effective in conserving water as the updated model ordinance, except as specified. Current law specifies the provisions of the updated model ordinance, as provided. Current law includes a related statement of legislative findings and declarations. This bill would require the updated model ordinance to include provisions that require that plants included in a landscape design plan be selected based on their adaptability to climatic, geological, and topographical conditions of the project site, as specified. The bill would also exempt landscaping that is part of a culturally specific project, as defined, ecological

restoration projects that do not require a permanent irrigation system, mined-land reclamation projects that do not require a permanent irrigation system, and existing plant collections, as part of botanical gardens and arboretums open to the public, from the model ordinance. The bill would require the updated model ordinance to include provisions that, among other changes, prohibit the use of traditional overhead sprinklers on all new and rehabilitated landscapes and require that new and rehabilitated landscapes use only water efficient irrigation devices. AB 1597 (Alvarez, D) Water quality: California-Mexico cross-border watersheds.

Summary: Current law establishes the California Border Environmental and Public Health Protection Fund in the State Treasury to receive funds appropriated in the annual Budget Act, including, but not limited to, proceeds of bonds sold as specified, and other sources, such as from the North American Development Bank (Nedbank), and makes money in the fund available, upon appropriation, to the California-Mexico Border Relations Council, a state entity. Money in the fund is used to assist local governments in implementation of projects to identify and resolve environmental and public health problems that directly threaten the health or environmental quality of California residents or sensitive natural resources of the California border region, among other purposes. This bill would authorize, upon appropriation by the Legislature in the annual Budget Act or another statute, funds to be made available to the California Environmental Protection Agency (CalEPA) for NADBank for loans, grants, and direct expenditures to address water quality problems arising in the California-Mexico cross-border watersheds. The bill would require the funding to be available for specified purposes, as provided, including water quality projects for the Tijuana River, and would make 10% of the funding available for the administrative costs of implementing these provisions. The bill would authorize funding provided for activities or projects in the State of Baja California to be provided through direct expenditures and for grants to an eligible funding recipient authorized to work in Mexico under a specified circumstance. The bill would require grant funding to be conditioned upon the enforceability and accountability requirements mutually agreed upon by CalEPA and NADBank, and would authorize CalEPA to withhold funding if the requirements of the applicable funding agreement are not met. AB 1820 (Schiavo, D) Housing development projects: applications: fees and exactions.

This bill would provide that the fees or charges for property-related water service imposed or increased, as specified, may include the incrementally higher costs of water service due to specified factors, including the higher water usage demand of parcels. Current law continuously appropriates moneys in the account for specified purposes, including, among others, the payment of grant moneys to eligible entities to assist in cleaning up a waste, abating the effects of a waste on waters of the state, or addressing an urgent drinking water need. This bill would require the State Water Resources Control Board to, no later than January 1 of each year, post on its internet website a report describing the receipts and expenditures of the State Water Pollution Cleanup and Abatement Account, as provided. A violation of the Hazardous Waste Control Law is a crime. Current law, beginning January 1, 2025, prohibits a person or entity from manufacturing, selling, delivering, holding, or offering for sale in commerce any cosmetic product that contains intentionally added perfluoroalkyl and polyfluoroalkyl substances (PFAS), as defined. This bill would similarly prohibit any person from manufacturing, distributing, selling, or offering for sale in the state any menstrual products that contain regulated PFAS, as defined. The bill would authorize the Department of Toxic Substances Control to adopt guidance or regulations, as specified, for the purposes of implementing and enforcing these provisions. The bill would require the department to issue a notice of violation of the above provisions under specified circumstances, including that the department has provided the manufacturer written notice of the alleged violation and, if mandated by the department, has failed to take corrective or mitigating actions to bring the product into compliance, and would specify when an initial and subsequent violations are deemed to have occurred. Current law makes a violation of the law or regulation adopted pursuant to the law a crime. Existing law requires, as a condition of licensure, a water-bottling plant, as defined, to annually prepare a water-bottling plant report, as specified, and to make the report available to each customer, upon request. This bill would require, in the event that the State Water Resources Control Board adopts a primary drinking water standard for microplastics, and upon adoption of that standard, any water-bottling plant that produces bottled water that is sold in this state to provide the State Department of Public Health's Food and Drug Branch an annual report on the levels of microplastics found in the source water used for bottling and in the final bottled water product that is offered for sale, as provided. This bill would, on and after January 1, 2026, instead apply the above prohibitions and requirements to any juvenile's feeding product or juvenile's sucking or teething product, as defined, that contains any form of bisphenol, as defined, at a detectable level above 0.1 parts per billion. The bill would authorize the department to establish standards for the juvenile's products above that are more protective of public health, sensitive populations, or the environment than the standards established by the bill. Summary: Current law requires an urban retail water supplier to calculate its urban water use objective no later than January 1, 2024, and by January 1 every year thereafter, and to be composed of the sum of specified data, including aggregate residential

Summary: The Porter-Cologne Water Quality Control Act authorizes the State Water Resources Control Board to certify or provide a statement to a federal agency, as required pursuant to federal law, that there is reasonable assurance that an activity of any person subject to the jurisdiction of the state board will not reduce water quality below applicable standards. The federal act provides that if a state fails or refuses to act on a request for this certification within a reasonable period of time, which shall not exceed one year after receipt of the request, then the state certification requirements are waived with respect to the federal application. Current law authorizes the state board to issue the certificate or statement before completion of the required environmental review if the state board determines that waiting until completion of that environmental review to issue the certificate or statement poses a substantial risk of waiver of the state board's certification authority under the Federal Water Pollution Control Act or any other federal water quality control law, as provided. Summary: Current law declares that all water within the state is the property of the people of the state, but the right to the use of the water may be acquired by appropriation in the manner provided by law. Current law requires the appropriation to be for some useful or beneficial purpose. Current law provides, however, that the diversion of floodflows for groundwater recharge does not require an appropriative water right if certain conditions are met, including that a local or regional agency that has adopted a local plan of flood control or has considered flood risks as part of its most recently adopted general plan has given notice, as provided, of imminent risk of flooding and inundation of lands, roads, or structures. Current law defines "floodflow" for these purposes, to include circumstances in which flows would inundate ordinarily dry areas in the bed of a terminal lake to a depth that floods dairies and other ongoing agricultural activities, or areas with substantial residential, commercial, or industrial development. Current law defines "imminent" for these purposes to mean a high degree of confidence that a condition will begin in the immediate future. Current law also requires the person or entity making the diversion for groundwater recharge purposes to file with the State Water Resources Control Board and any applicable groundwater sustainability agency for the basin, a notice containing specified information no later than 48 hours after initially commencing diversion of floodflows for groundwater recharge, a preliminary report no later than 14 days after initially commencing that diversion, and a final report no later than 15 days after the diversions cease. These requirements apply to diversions commenced before January 1, 2029. This bill would also require an entity making the diversions for groundwater recharge that is required to file the notice and the reports, including the final report, as described above, with the board and the applicable groundwater sustainability agency for the basin, to also file those documents with the agency that issued the applicable flood determination. The bill would require the final report to contain information, if applicable, describing the forecasting models used to determine a likely imminent escape of surface water and a description of the methodology used to determine the abatement of flood conditions. Progress on OCWD / MWDOC Merger Study

At the September 10th meeting of OCLAFCO, executive director Carolyn Emory announced that the study regarding a focused review of potential consolidation of OCWD and MWDOC should be completed and publicly released in late October. The long awaited study conducted by Riverside's Albert A. Webb and Associates will not be fully reviewed by OCLAFCO until early 2025.

In another action, it appears discord has broken out between the six Southern California LAFCOs and CAL-LAFCO regarding the realignment of the CAL-LAFCO legislation model. The CAL-LAFCO Board at this year's July 19th meeting approved the elimination of the long-standing legislative committee. Instead, CAL-LAFCO is proposing a professional advocacy model, similar to the model employed by CSAC. Part of the recommendation also transfers a shift of responsibilities from the CAL-LAFCO executive director to regional offices. LAFCO staff listed many concerns with the changes. During the meeting, Commissioner Derek McGregor, expressed frustration with and opposition to the changes. He noted the changes were so significant and mistaken that if CAL-LAFCO turns a deaf ear to local LAFCO concerns; it could lead to a push to replace the CAL-LAFCO executive director or a withdrawal from the committee's membership. Stayed tuned.



Fire Emergency Declaration Highlighted Board Meeting

At the September 11th meeting of the O.C. Board of Supervisors, the Board voted to finally end the declaration for the *Tustin Blimp Hanger Fire*. However, the Board also passed a declaration regarding the *Orange County Airport Fire*. The purpose of the declaration is to make it easier to seek federal funding for the fire fight.

As of September 16, 2024, the fire had burned 23,519 acres and was 41% contained. Easterly winds and topography drove the fire towards the Lake Elsinore area. At last count, 194 structures including homes and commercial have been damaged or destroyed.

Luckily for Orange County, this fire was not accompanied by Santa Ana winds. The disastrous *Santiago Canyon Fire* of September 1889 was Santa Ana wind fueled. That fire ultimately consumed 308,000 acres. A Santa Ana wind this time could have imperiled the Tustin, Orange and Anaheim foothills.

The second item of interest dealt with was the stripping of all committee assignments of embattled Supervisor Andrew Do. Do, who only has a few months left on his Supervisor term, has been sued by the County for his role in steering funds to charities which may have not provided services that were contracted for. Also caught up in the legal mess is Do's daughter, who profited from one of these groups. Supervisor Do's home and office were searched by the F.B.I.

One of the committees Do was removed from is the Orange County Transportation Authority. There is a question as to whether the Board can do that since the Supervisor's membership is a by-product of state law.

These last eight years Do's office, and in particular his staff, have been accessible and helpful. This comes as a complete shock.


California Earthquakes on the Rise

When a 4.7 magnitude earthquake rumbled through the Malibu area on September 12th, it marked the fourteenth 4.0 or greater earthquake in California this year. According to world renown seismologist, Lucy Jones, this means that in 65 years of studied earthquakes, 2024 just surpassed the record for the number of independent 4.0 earthquakes in any year in California. She notes that whether or not that mark is statistically significant is up in the air.



Presidential Contest Update

In the wake of former President Donald Trump's sub-par debate performance, Kamala Harris received a minor positive bump in the national polls. Nevertheless, the battle for swing states electoral votes remains razor thin close.



If all of the 42 non-swing states vote as predicted, the easiest path to a Trump victory would be sweeping Georgia, North Carolina and Pennsylvania. That feat would provide him with exactly 270 electoral votes . . . the magic number needed. If he loses either North Carolina or Georgia, Trump can still win by carrying both Arizona and Nevada. If he can carry either Wisconsin or Michigan the path becomes much easier.

Cities Coalesce Behind Green Agenda

In 2005, the former mayor of London, Ken Livingston founded the C 40 Cities Initiative, an organization of international cities committed to fighting climate change. As of 2024, 97 large cities, including 14 from the U.S. have adopted the goals set forth by the organization.

Their premise is that cities can impose climate controls in excess of national limits. The 97 cities account for 10% of the world's population. Their overriding goal is to influence green policies around the world to limit world temperature rise to no more than 1.5 degrees Celsius from pre-industrial levels.

The following are some of the strategies the cities wish to attain:







Background

At the Urban Water Institute (UWI) Board of Director's (BOD) meeting held on August 22, 2024, one of the items discussed was membership rates for 2025. An Ad-Hoc Committee was formed to begin the process of enhancing UWI's fixed income (currently membership dues) to cover fixed operating costs while ensuring the UWI continues to operate in a cost-effective manner. The Ad-Hoc will be working over the next few months to formulate a recommendation for UWI BOD approval.

The UWI BOD did unanimously approve a new UWI membership category: the *Board Chair's Circle*. The membership fee was set at \$5,000. The following organizations expressed a desire to become members of the *Board Chair's Circle*: Mesa Water, Irvine Ranch Water District, Moulton Nigel Water District, Water Replenishment District, and Yorba Linda Water District. At a minimum, there will be special recognition at the conference in Palm Springs 2025 for the organizations and companies that will constitute the charter members of the *Board Chair's Circle*.

EOCWD has been very supportive of UWI's efforts in the past. Director Thoms currently holds a Board seat and the EOCWD Board routinely attends the semi-annual conferences to keep abreast of current issues and discover reliable solutions to the challenges faced in the water/wastewater utility world.

This would be an increase of \$4,450.00 in our annual membership fee.

Approve EOCWD's membership renewal as a Charter Member.

DATE: SEPTEMBER 26, 2024

Background

The District's Supervisory Control and Data Acquisition (SCADA) improvement program was envisioned originally as three phases. Phase 1 was replacing the SCADA primary and backup servers and installing new operating software. This project was completed in 2022. The SCADA Phase 2 Project (Project) will replace and upgrade existing SCADA software, hardware, and communication equipment at the District's field sites. Phase 3 would extend the system to include District's facilities that do not currently have data transfer capability. That work is scheduled following completion of Phase 2.

At the April 21, 2022 meeting, the Board awarded the Project to Tesco Controls, Inc. (Tesco). The contract was amended on December 15, 2022 to add a Remote Telemetry Unit control panel to the OC43 Walnut vault and on September 25, 2023 for programming at Barrett Pump Station and cybersecurity upgrades. Tesco began the Project, providing the engineering and equipment. However, Tesco's contracts were terminated due to non-performance.

A Request for Proposals to complete Phase 2 was issued to W.M. Lyles System Integration Division (W.M. Lyles), Enterprise Automation (EA), and Big Bear Electric. Proposals were received from W.M. Lyles and EA. Big Bear Electric's proposal was submitted after the deadline. W.M. Lyles proposed an excellent team, a schedule of meeting deadlines, value addition to review existing architecture for compliance with best practices, and the least cost in the amount of \$295,000 compared to EA's \$344,138. Staff recommends awarding the project to W.M. Lyles in the amount of \$295,000 and including a \$50,000 contingency.

Staff is recommending an increase in the amount of \$65,000 to the overall Project budget to complete the work as summarized below. The increase represents additional effort needed for the recovery work by EA, increased contingency, and WM Lyles scope.

A similar adjustment to the CIP program may be needed after balancing the unspent funds left in reserves with the increase in project costs. An update of the overall CIP program and budget will be reviewed with both the Operations and Engineering Committee and the Board at the midpoint of the physical year. Any adjustments to the overall CIP will be addressed at that time.

This item was reviewed by the Engineering and Operations Committee at the meeting on September 13, 2024. This memo was revised substantially since that meeting. It should be noted that there is some urgency to the Phase 2 work since our existing copper wire communications may not be available after December of this year.

Recommendation

That the Board:

- Increase the SCADA Phase 2 System Improvements Project (Project) budget by \$65,000 for a new Project budget of \$950,000.
- Award a Professional Services Agreement to W.M. Lyles in the amount of \$295,000.
- Authorize and approve the General Manager a \$50,000 contingency to complete the Project.
